



# Certification Procedure under the Republic of Turkiye Halal Standard System



## 1. Complete the Application / Prepare the Documents

Download the application form at [www.halal.or.th](http://www.halal.or.th) > [OIC/SMIIC Halal Standard application form](#)

The Entrepreneur must be certified under CICOT, including the products intended to be certified under the international certification system



## 2. Submit Documents

Submit documents to the Provincial Islamic Office to file documents to CICOT

In case the establishment is located in province which have no Provincial Islamic Office, the Entrepreneur shall file documents to CICOT directly.



## 3. Pay Fees

Inspection and Certification fees according to the CICOT Regulation No. CICOT 06.105-2567 Dated 12 March 2567 (B.E.)



## 4. Documents Review by Officers

Submitted documents completeness and correctness review by Officers of Halal Affairs



## 5. Audit Stage 1

Auditing of the Establishment On-site or/and Online and documentize the results into report by Halal Science Officers



## 6. Audit Stage 2

Auditing of the Establishments On-site and documented the result into report by Science and submit to the screening working committee



## 7. Submission of the Auditing Result to the Halal Affair Subcommittee

Auditing results are submitted to the Halal Affairs Subcommittee for review and consideration of approval



## 8. Notificaton of Certified Results

Certification results shall officially notified to the entrepreneur



## 9. Submission of certification documents to cicot

Certification results shall officially notified to the entrepreneur in PDF format.
