1. The importing company must be registered with the Halal Center through the online system.
2. The establishment must be listed on the Saudi Food Safety Authority (SFDA) approved list of slaughterhouses and meat processing facilities.
3. registration Halal Center

The establishment must be registered with the Halal Center of the Kingdom of Saudi Arabia through the online system. The application is submitted by CICOT, and the registration fee is THB 112,500 / 3 year.
